

# **TERMS AND CONDITIONS**

# A. Schedule to Conditions of Entry

3.	Promotion Period:	The Promotion starts at 00:00:00 on 01/05/2023 and closes at 23:59:59 on 20/08/2023.
4.	Eligibility:	a. The Promotion is open to all legal residents of Malaysia with a valid identification document, aged 18 years and above as at the start of the Promotion Period that registers as a NEW Dear Nestlé member with any Nestlé Promoters at any Nestlé on-ground activation or Nestlé events during the Promotion Period.

# 8. <u>Judging Details</u> <u>- Monthly</u> <u>Prizes:</u>

#### 1. Introduction
